Also an update, in case you missed it: On January 3, 2018 the PA DEP suspended the permits for this pipeline. Sunoco has been told that they may not proceed without written permission from DEP. 10 THINGS YOU CAN DO

- **1 Recycle** Less than 14% of plastic packaging is recycled.
- **2 Go on a Plastics Diet** 90% of the plastic items in our daily lives are used once and then thrown away.
- **3 Ban the Bags** Urge elected officials to follow the lead of the State of California. San Francisco, Chicago and 150 other cities and counties by introducing and passing legislation that will ban the use of plastic bags or impose a use-fee per bag.
- 4 **Stop Buying Water in Plastic Bottles** Each year, close to 20 billion plastic bottles of water are tossed into the trash.

 - 8 Bring your own Garment Bag to the cleaners Invest in a zippered fabric bag and request that your cleaned items be returned in it instead of plastic.
 - 9 **Consumer Rights** Contact corporations and ask them to use less plastic packaging and more recyclable containers.
 - **10 Get the word out** Tell your friends and community about ways to cut back on the growing use of plastics. It can make a BIG difference for our oceans.

The National Affairs and Legislation and Conservation Committees recently sent a letter to the Department of the Interior Secretary Ryan Zinke. The letter voices strong opposition to the President's executive action to reduce the boundaries of Bears Ears National Monument in southeastern Utah and Grand Staircase-Escalante National Monument in southwestern Utah by approximately two million acres. The committees called on the Executive Branch to take no action on these lands while the President's decision is being adjudicated in the courts. In forwarding the letter to the Chairmen and Ranking Members of the U.S. House of Representatives' Resource Committee and the U.S. Senate Committee on Energy and Natural Resources, the committees hopes to highlight their concern about the potential reduction of other monuments, including marine monuments, under review in the Department of the Interior. The committees pointed out that the GCA was one of the earliest private non-profit groups to support the protection of designated national conservation lands and that have continued to be actively engaged in that support every since. Dear Secretary Zinke,

We are writing to voice our strong opposition to President Trump's executive action to reduce the boundaries of Bears Ears National Monument in southeastern Utah and Grand Staircase-Escalante National Monument in southwestern Utah by approximately two million acres. We are also quite concerned about the potential reduction of other monuments, including marine monuments, under review in your department. These national monuments contain invaluable natural, historic, and cultural resources that should and indeed must be permanently protected for the good of the American people. That is what Congress envisioned when it passed the Antiquities Act of 1906 and that spirit has been upheld by every Administration in both the Republican and Democratic parties ever since.

Founded in 1913, The Garden Club of America (GCA) is a volunteer, nonprofit 501(c)3 organization comprised of 200member clubs and approximately 18,000 club members throughout the country. The GCA members passionately devote their energies and expertise to a wide array of conservation projects in their communities and across the nation. We are one of the earliest private non-profit groups to support the protection of designated national conservation lands and have continued to be actively engaged in that support.

The Garden Club of America believes that monument designations protect lands with irreplaceable treasures whose value is incalculable. These public lands deserve the highest possible level of protection. Drastically minimizing the monuments' size and opening once-protected lands to development, agriculture, mining, and other uses is an attack on treasured historic and natural wonders.

We urge the President to reconsider his decision. At a minimum, we call on the Executive Branch to take no action on these lands while the President's decision is being adjudicated in the courts. We also encourage Congress to take steps necessary to protect the cultural, ecological, and tribal treasures on America's public lands.

Sierra's Big Win in Court builds on State Supreme Court Decision

The landmark Article I § 27 win by PEDF's John Childe is being felt in again in a new court decision.

Settlement Forces Coal-Fired Plants to Reduce Toxic Pollutants in Waterways

Three Pennsylvania conservation groups used Article I § 27 of our State Constitution and the Federal Clean Streams Act to win a settlement which will insure that coal-fired power plants operate under current water permits.

Those power plants are some of the largest sources of toxic water pollution in the state, discharging toxic arsenic, boron, cadmium, chromium, lead, mercury and selenium.

Arsenic causes cancer; mercury is highly toxic; and selenium can have short and long-term health impacts.

Sierra Club and the Lower Susquehanna Riverkeeper,

represented by PennFuture and the Law Office of Howard Crystal, <u>have filed a settlement</u> with the Pennsylvania DEP that will reduce toxic pollution in waterways from 10 coal-fired power plants that had been operating in the state with expired water permits.

Building on the Pennsylvania Environmental Defense Foundation's landmark win in the State Supreme Court, groups alleged that the ongoing discharge of pollutants into waters of the Commonwealth violated the Article 1 Setion 27 (the Environmental Rights Amendment) of the Pennsylvania Constitution.

The settlement is a big step in the right direction for Pennsylvania streams and public health. The PA DEP agreed to a schedule to update and draft new water permits over the course of the year for all of the coal plant.

Patrick Genter, Senior Campaign Representative for the Chesapeake Bay at the Sierra Club said. "Not only does this mean cleaner and safer drinking water for communities, but also a healthier environment, which can lead to increased recreational opportunities for fishermen and all those who enjoy our waterways."
